- After a visit with the owner of CNA, the Heart of Nursing, Ms. Lewis informed CPSCR that she is closing her school in McComb and relocating to Texas. All students have completed their programs on October 12th. Her certificate expired in August 2023.
- Follow-ups from the August meeting:
 - Last meeting we discussed Ms. Amber Jackson and her return to CPSCR. Dr. Verneuille spoke with Ms. Jackson and she is still working to secure the right location for her school. She will CPSCR for a sit-down once she has this completed.
 - An email sent to Ms. Sherren Smith with Dream Chaser's about reviewing her teaching lab for final step in the surgical technician program approval. Ms. Smith has not returned any of communications to setup a time. She was informed the program is not approved until a review is done.
- In September, Dr. Verneuille visited three schools: Ocean pointe Dental Assisting Academy of Crystal Springs, CE Career Center, & Copiah Learning Institute.
 - All three facilities and instructional areas were toured. No classes were in session at the time of the visits.
 - CE Career is currently on voluntary suspension. However, Ms. Edwards is hoping to have her renewal paperwork and fees ready to return this December.
 - While in Natchez this week, Dr. Verneuille had a chance to stop by the new location for Coastal Truck Driving School. They are no longer collaborating with Co-Lin Community College as of this summer and are strictly independent now. The new location is on a main road into Natchez, highly visible and suited for CDL training.
- MS School of Health Services & Careers moved to a new location from Pearl to Brandon.
- Delta Technical College moved the training area for electrical to the annex previously only used by the CDL program.
- Unitech Training Academy reported they will no longer be offering the following programs in MS. These programs are being incorporated into IT Technician program.
 - Microsoft 365, Computer Networking, Network Security, and Microsoft Azure
- Dr. Verneuille proposed a new disclosure to add to the CPSCR exemption letter regarding schools using the exemption for tuition-free courses. Previously, the

Commission determined to use of the Exemption Item A in the CPSCR statute which allows the exemption from registration with CPSCR if the school is offering tuition-free training for the own employees to be used if schools were offering free training and the students were not any out-of-pocket fees if the students were for other businesses.

- A new business model is coming more popular to offer training for other businesses though applying grants, WIOA, funds, other businesses covering the training. Dr. Verneuille found in asking more questions that the students might be required to cover their certification costs, tools costs, etc.
- Since the exemption does not specifically cover this model, proposal to add an additional disclosure on all advertising that "All courses/programs are completely free of charge, with no fees paid by the student." to qualify for this exemption.
- Since these programs/courses are no reviewed or monitored by CPSCR, as long as the student is not out any money, they have the opportunity to get free training with CPSCSR's involvement only if the student were to only be out their time.
- Dr. Verneuille presented the current Enrollment/Graduation Numbers being reported to the Education Achievement Council in October.
- Nine schools have not submitted their GAT for FY2023. These schools will be notified they have until 10/31 to submit and pay their fees or late fees of \$500 will begin 11/1/2023 every month and they are risking suspension of their certificates.
