- Tuition Increase Requests:
 - CPSCR received request for tuition increases at from Accelerated Dental Assisting Academy.
 - Tuition will increase by \$260 to incorporate the CPR tests and operating costs.

- Lincoln College of Technology notified CSPCR they have discontinued the Automotive Technology with AUDI Education Partnership as of January 29, 2020 due to a lack of demand. No current students were enrolled.
- CPSCR was notified by the Federal Student Aid Dept. that the Institute of Health & Technology has been put on Heighten Cash Monitoring Level 1. This is the second year in a row for not meeting the minimum composite score as required by all title IV schools. Institutions are required to maintain a minimum score of 1.5 out of 3.0. IHT's score is 1.2. The report states the IHT was on Zone Alternative reporting last year. In this option, the school must make a refunds and disbursement to students before they can drawdown funds from the Dept of Education for the current students. This provision is allowed for three consecutive years. After which, the school may lose title IV eligibility.
- Follow up on Stepping Stones Career College: CPSCR was notified of the cancellation of both bonds (school & agent) for Stepping Stones Career College. Since Dr. Verneuille had not been able to get in touch with Ms. Knowles, she went up to Louisville to check on the school. The building was closed but Dr. Verneuille left her card asking for Mrs. Knowles to contact CPSCR. About a week later Kelvin Knowles, the owner's son, called. Kelvin let informed Dr. Verneuille know that his mother had been diagnosed in May 2019 with stage 3 cancer and passed away in September 2019. Mr. Knowles is considering opening a new school, but is looking into funding to make sure the business is successful.
- Student Records: Antonelli College has work out there issues with Parchment who will be the official repository for the school's transcripts upon official closure. Classes will be complete this by February 25, 2020. The registrars will take a couple of weeks to officially process all active student records and transmit them to Parchment. CPSCR has asked to have a copy of those records that we will house on our servers.
- Dr. George Terry submitted his resignation as Commissioner representing the 4th Congressional District on Wednesday, February 12, 2020.
 - CSPCR is presently working with Audra Kimble and Kell Smith to find someone to fulfil his term.

CPSCR has received a records request from Antonelli College. Mrs. Debbie Moore has informed CPSCR they have around 400 boxes of student records from prior to 2016. CPSCR does not need these records which include financial information and protected FERPA issues. With the school being out of funds to dispose of these records, Antonelli College has asked for assistance from CPSCR to dispose of these records. The cost to shred the records is approximately \$6.00 a box for a cost of around \$2400. CPSCR plans that make a claim on the schools bond for reimbursement once all the expenses have been done to the final closure. Dr. Verneuille believes the final cost are going to be around \$5000 total

Upon a request to start a discussion on a request to spend CPSCR funds to close out Antonelli College records, motion was made by Dr. Dean Belton and a second by Ms. Esther cash was made.

Mr. Donald Benjamin asked is CPSCR has the authority to commit funds to these tasks and if so would we need a quote. Tommy Goodwin stated CPSCR is not required to have a quote and asked our guidelines fall under the internal purchasing for the agency. Dr. Verneuille stated that in the past CPSCR has taken care of the disposal of records form previously closed schools that have voluntarily relinquished there records to CPSCR possession. The request will go through the proper channels of approvals with finance and Dr. Mayfield before the funds are spent.

Tuition Decrease:

- Last meeting, CPSCR received request for tuition increases at from Accelerated Dental Assisting Academy.
 - Tuition will increase by \$260 to incorporate the CPR tests and operating costs.

- The school is holding off on that increase and offering their lowest tuition rate (early signup rate) for the next class.
- Three schools have asked for extension on their renewals:
 - o Compusystems Inc. Greenville
 - o Blue Care Medical Academy Southaven
 - o Grant Allied Healthcare & Training Institute Greenville, MS
- Systems IT, Inc. has notified CPSCR they closed the training center at the end of 2019.
- Friends of Children has notified CPSCR they do not plan to renew the certificate of registration.
 - This school registered with CPSCR in April 2004. They offer many programs that are grant based and free of charge. The school offerings shifted of the years to many child development programs. With Dr. Marvin Hogan's retirement this year, they have decided not to renew.
 - o Formal statement coming from school stating they are not engaging in activities that would require their registering with CPSCR.
- Antonelli College is officially closed this month. Due to this health crisis, CPSCR
 have not had the time to retrieve the records from the school's possession. Mrs.
 Moore is making sure to keep the records safe until we can make the time to
 finish up with the final steps.
- Regarding the health crisis, CPSCR schools were sent guidelines for operating through this time. Each school has responded. Most schools have moved to some type of online classroom instruction or were limiting their classes to under 10 students prior to the Governor's Shelter in place order. Dr. Verneuille reported that she had not heard recently for all the school's if their operation changed but have encouraged them all to follow CDC guidelines and those of their local city mayors. Administrators were told that there are no clinical sites open to students in MS for any allied health. These will need to be postponed until they reopen to students. Universal Technical Institute has notified CPSCR they have extended their temporary mode delivery through June 30th. Most schools have extended their online delivery plans through April 30th.
- Update on the Truck Driving Industry
 - O Governor Reeves indicated in his Shelter-in-Place order that the trucking industry and their support were deemed essential business. The National Trucking Assoc. sent a message to school that they were encouraging all Governor's to exempt the schools from any orders to close as they were supporting the industry.
 - Presently, in MS, the centers issuing CDL licensing are open and students can still obtain their permits.
 - CPSCR has 8 trucking schools. All but Truck Driver Institute (Saucier & Tupelo) are operating while following the CDC guidelines of limiting to 10 students in the classroom, cleaning the trucks, wearing masks & gloves,

and limiting behind-the-wheel (BTW) training to one to one. TDI is teaching their current class and then suspending class. They will assess each week as MS progress through the health crisis.

- that Ralph Fitzgerald, director for the Ridgeland campus has taken family leave and the school has temporarily put Juanita Luse, the Director of Education as the campus director until Fitz's return.
- Antonelli College Closure Update: Dr. Verneuille reported that a digital copy of all transcripts have been submitted to CPSCR. The submission was batched differently than hoped for from the School. The Parchment group also has the transcripts except for the student that attended the online campus. CPSCR will get that information formatted for Parchment so they will have all transcripts.
- Verneuille reported that a new agent application for the Memphis campus was not fully submitted and the agent has been working without an approved license. The timeline for the application suggested that the staff at Concorde CC in Memphis made mistake and forgot to fully submit the applicant to CPSCR once it was completed in February 2020. Dr. Verneuille held a meeting with the corporate compliance division (John Carreon and Kristen Marshall) at Concorde to discuss the repercussion of having an unlicensed agent enrolling students at the campus. Concorde's research the issues and found that only one student had been enrolled by this agent. The school has refund all fees paid for this student and the student will continue to complete their program free of charge. Dr. Verneuille will be setting a time for training with the Memphis staff to assure this problem does not happen again. Further discussion can be done during the docket if necessary. Staff has a docket item on this agent's approval and recommended solution of approving the application for a February 2020 date when the app was completed.
- Program Modifications: Two schools requested approval from CPSCR of an additional to some programs of a permanent addition of a hybrid/distance learning component.
- Health Crisis/Pandemic Update: Presently, the MS Dept. of Health is temporarily allowing CNA schools to develop an in-house lab environment for student to obtain their clinical hours until restrictions are lifted by the nursing homes.
 Several schools opted to the in-house labs. Some had suspended their CNA programs due to the clinical issue, so this option should help schools with their programs.
- Cyanna contract for Edvera is in the last year. It has been very productive in my workflow, especially during the pandemic. Dr. Verneuille will be talking with Allison Jenkins of a new contract over the next several months.
